## Pinnacle Park Permit

1. You must possess and retain this permit while hiking or camping.
2. Camping is permitted in designated site only, marked on the map 1-5.
3. Open fires are prohibited except in designated camping sites within fire rings. Only dead or downed wood is to be burned.
4. Food Storage: When not being transported or consumed, all food must be suspended at least 10 feet from the ground and no less than 4 feet from the closest limb or tree trunk.
5. Trash: All trash must be packed out. Stored trash must be suspended at least 10 feet from the ground and no less than 4 feet from the closest limb or tree trunk.
6. Toilet use must be at least 100 feet from any camp site or water source.
7. All vegetation, wildlife, and natural structures are historic and protected by law on this property.
8. Do not cut, carve or deface any trees or vegetation.
9. Motorized vehicles are not permitted in the Park and are prohibited by law.
10. Alcoholic beverages are prohibited by law.
11. There is a 3 night maximum stay for camping.
12. Hunting or trapping any animal or bird within the Park is prohibited.
13. Possession of a firearm or weapon in Pinnacle Park is prohibited.

**\*Violation of these rules is a criminal offense punishable by any applicable criminal state law or if none, the same constitutes a Class 3 misdemeanor pursuant to NCGS 14-4 and Town Ordinance 1-7.**
